



Outdoor Living Collection 1-Year Limited Product Warranty

This warranty covers all inherent defects in material, and also covers PermaShield protected granites from common food and beverage stains, arising under normal usage and care, in this natural stone product for a period of one (1) year from the date of installation provided you are able to present a valid proof-of-purchase and valid proof of installation, and provided this product was fabricated and installed by Innovative Stone LLC or its authorized service provider. A valid proof-of-purchase is an authorized retailer or authorized service provider receipt, specifying item, date purchased, cost of item, and showing full payment. Valid proof of installation includes your customer code assigned on the Warranty Activation Form and your registration of this warranty. Product warranty is intended for residential outdoor use only. Any commercial use voids the warranty.

YOU MUST KEEP THE ORIGINAL PROOF-OF-PURCHASE TO OBTAIN WARRANTY SERVICE

Who is covered?

- The *original* retail purchaser who can provide a valid proof-of-purchase and who has submitted warranty activation including the assigned customer code on the Warranty Activation Form to Innovative Stone LLC via US mail or online within 60 days of product installation. Failure to appropriately activate the warranty of this product or failure to follow the care and use instructions will void this warranty and will prohibit the transfer of warranty coverage to a secondary owner.
- A *secondary* owner who can provide a valid transfer of ownership document and original proof-of-purchase. A valid transfer of ownership document is a notarized letter from the original owner, dated within 180 days of the original purchase of this product, which transfers ownership and warranty rights of this product to a named secondary owner. The original purchaser's failure to appropriately activate the warranty of this product will prohibit the transfer of warranty coverage to a secondary owner.

What will be done?

- During the applicable warranty period under normal usage and care, Innovative Stone LLC at their discretion, will repair or replace with the same or comparable product, should it prove defective. Exact color match cannot be guaranteed, as stone is a product of nature.
- Innovative Stone LLC's obligation will be limited solely to the cost of the repair or replacement of the actual countertop and will not include any additional costs such as labor, or incidental repairs, or modifications.
- The repaired or replacement product is warranted for the remaining balance of the original warranty period.
- The warranty holder must at all time reasonably assist Innovative Stone LLC in the repair or replacement process by providing access to the premises, receiving any products sent for this purpose, and following all instructions for removal of food and beverage stains.

- Product moved from its original place of installation.
- Any commercial use.
